## **Privacy Policy**

## **Definitions**

#### Service

Service is the https://www.wwslbda.com website operated by W&W Solutions Ltd..

#### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

#### **Usage Data**

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### Cookies

Cookies are small files stored on your device (computer or mobile device).

#### **Data Controller**

Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed.

## Information Collection and Use

## **Types of Data Collected**

#### **Personal Data**

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally, identifiable information may include, but is not limited to:

- Cookies and Usage Data

#### **Transfer of Data**

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of Bermuda, or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.

If you are located either inside or outside Bermuda and choose to provide information to us, please note that we may transfer the data, including Personal Data, to Canada and process it there. Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

W&W Solutions Ltd. will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.
